GENERAL JUDGMENT

This matter comes before the Court following the Court of Appeals’ reversal and remand of the Court’s July 29, 2021 judgment dismissing the proceeding. In its opinion, the Court of Appeals held that this matter is justiciable, and that the Columbia County Second Amendment Sanctuary Ordinance, “is preempted by ORS 166.170 and void.” *Board of Cty. Comm. of Columbia Cty. v. Rosenblum*, 324 Or App 221, 243 (2023).

NOW, THEREFORE, based on the above, this court's prior judgment entered on July 29, 2021, is VACATED and this court hereby enters a Final Judgment as follows:

Now, being fully advised, it is hereby ADJUDGED, and the court declares, that for the reasons set forth in the Court of Appeals’ Opinion, Exhibit A to Columbia County Ordinance No. 2021-1, “the Columbia County Second Amendment Sanctuary Ordinance,” is preempted by ORS 166.170 and void.
