ORDER

This matter coming before the Court on Defendant Glock Ges.m.b.H.'s presentment of its motion to dismiss, filed March 12, 2025, the parties having appeared by counsel, and the Court being fully advised, IT IS HEREBY ORDERED THAT:

1. To conserve judicial resources, and because the Court will not rule on the same issues more than once, Defendant Glock Ges.m.b.H.'s motion to dismiss is ENTERED AND CONTINUED until the Court rules on the pending motions to dismiss previously filed by the other Defendants.
2. At such time as the Court rules on the motions to dismiss filed by the other Defendants, Glock Ges.m.b.H. may modify its motion to address only issues not resolved by the Court's ruling on the motions to dismiss by the other Defendants. Glock Ges.m.b.H. may also move to reconsider any issues decided adversely to it in the Court's ruling on the motions to dismiss by the other Defendants.
3. Glock Ges.m.b.H.'s previous motion to dismiss, filed on October 30, 2024, is ordered WITHDRAWN. All briefing deadlines and the hearing date set for the previous motion to dismiss (May 19, 2025), which were entered in the Court's order of January 21, 2025 are HEREBY STRICKEN.
4. This order does not modify any prior orders regarding the motions to dismiss filed by the other Defendants and the hearing on such motions remains set for in person oral argument on **March 21, 2025 at 2:00 p.m.** in Courtroom 2402. 5. By no later than **March 19, 2025**, one attorney for Defendant Glock, Inc. shall email the Court all courtesy copies of the briefing on the pending motions to dismiss that will be argued on March 21, 2025.
